GPA's will be calculated and transmitted automatically for eligible college students.</li> <li>• Deadline to submit a <a href="#">California Dream Act Application for Cal Grant</a> Entitlement award consideration.</li> <li>• Deadline for priority consideration for 2019-2020 Federal SEOG and Federal Work Study. The Central Processing System (CPS) must receive your FAFSA by this date. <b>SEOG and FWS funds are limited. If funds remain after awarding students who have met the priority deadline of March 2nd, the colleges will continue to make awards on a first-come, first-serve basis.</b></li> </ul> |
| September 2, 2019 | <ul style="list-style-type: none"> <li>• Second Competitive Cal Grant opportunity for California Community College students only.</li> <li>• CSAC must receive your <a href="#">GPA Verification</a> and you must file a FAFSA by this date for Cal Grant consideration. GPA's will be calculated and transmitted automatically for eligible college students.</li> </ul>   |
| December 14, 2019 | Deadline to submit <a href="#">2019-2020 FAFSA</a> for students who last attended <b>Fall 2019</b> .  |
| March 16, 2020    | Deadline to submit <a href="#">2019-2020 Verification Documents</a> to MJC for students who last attended <b>Fall 2019</b> . <i>Date must be adjusted if the last day enrolled is prior to end of the semester, such as in a withdrawal.</i>  |
| May 2, 2020       | Deadline to submit <a href="#">2019-2020 FAFSA</a> for students who last attended <b>Spring 2020</b> .  |
| June 30, 2020     | FAFSA: Deadline to submit <a href="#">2019-2020 FAFSA</a> for Summer 2020 grants which is <b>valid only for students attending Summer term</b> .  |
| June 30, 2020     | Paper BOGW: Last day to submit the <a href="#">2019-2020 California College Promise Grant (formerly known as Board of Governors Fee Waiver)</a> paper application.  |
| August 3, 2020    | Deadline to submit <a href="#">2019-2020 Verification Documents</a> to MJC for students who last attended <ul style="list-style-type: none"> <li>• <b>Spring 2020 and/or</b></li> <li>• <b>Summer 2020</b></li> </ul>   |
