March 4, 2024	<ul style="list-style-type: none"> <li>• Deadline to submit a <a href="#">Cal Grant GPA Verification</a> to the California Student Aid Commission (CSAC). GPA's will be calculated and transmitted automatically for eligible college students.</li> </ul>
April 2, 2024	<ul style="list-style-type: none"> <li>• Deadline to file a completed <a href="#">FAFSA</a> for Entitlement and primary Competitive Cal Grants.</li> <li>• Deadline to submit a <a href="#">California Dream Act Application for Cal Grant</a> Entitlement award consideration.</li> </ul>
August 2024	Awarding Federal Supplemental Educational Opportunity Grant (FSEOG) and Federal Work Study (FWS) for the 2024-2025 year to eligible students with a complete financial aid file. <b>FSEOG and FWS funds are limited. If funds remain after awarding students, the colleges will continue to make awards on a first-come, first-served basis.</b>
September 3, 2024	<ul style="list-style-type: none"> <li>• 2<sup>nd</sup> Competitive Cal Grant opportunity for California Community College students only.</li> <li>• CSAC must receive your <a href="#">GPA Verification</a> and you must file a FAFSA by this date for Cal Grant consideration. GPA's will be calculated and transmitted automatically for eligible college students.</li> </ul>
December 13, 2024	Deadline to submit <a href="#">2024-2025 FAFSA</a> for students who last attended <b>Fall 2024</b> .
March 14, 2025	Deadline to submit <a href="#">2024-2025 Verification Documents</a> to MJC for students who last attended <b>Fall 2024</b> . <i>Date must be adjusted if the last day enrolled is prior to end of the semester, such as in a withdrawal.</i>
May 2, 2025	Deadline to submit <a href="#">2024-2025 FAFSA</a> for students who last attended <b>Spring 2025</b> .
June 30, 2025	FAFSA: Deadline to submit <a href="#">2024-2025 FAFSA</a> for Summer 2025 grants which is <b>valid only for students attending Summer term</b> .
June 30, 2025	Paper BOGW: Last day to submit the <a href="#">2024-2025 California College Promise Grant (formerly known as Board of Governors Fee Waiver)</a> paper application.
July TBD, 2025	Deadline to submit <a href="#">2024-2025 Verification Documents</a> to MJC for students who last attended <ul style="list-style-type: none"> <li>• <b>Spring 2025 and/or</b></li> <li>• <b>Summer 2025</b></li> </ul> <i>Date must be adjusted if the last day enrolled is prior to end of the semester, such as in a withdrawal.</i>
